Carla van Baalen led the Dutch Centre for Parliamentary History in Nijmegen for nearly a quarter of a century. She just retired, still smiling and remaining as active as ever. Her colleagues, including the author of this editorial, were keen to collect their memories and professional tributes in a festschrift characteristically entitled "She Thrives in Cooperation".

Another founding EuParl.net member, the German Commission for the History of Parliamentarism and Political Parties, or KGParl, celebrated its 70th anniversary. Set up in 1952 as an elite expert body in West Germany, it survived the political turmoils of the 1960s and 1970s, to finally come under the auspices of the Bundestag of reunified Germany and move to Berlin in 2006.

It is a great pleasure to share these events with our much loved and respected colleagues. Even more so given they also represent model institutes that do cutting edge research into parliamentary cultures, while keeping ample autonomy from their patron institutions. KGParl Turns 70

On 6 May, the jubilee was kicked off by a public gathering in the Haus der Bundespressekonferenz in Berlin. The room known as the venue of Angela Merkel's press conferences hosted a keynote lecture by Paul Nolte from the Freie Universität Berlin and a panel discussion on the challenges that representative democracy now faces.

PROJECTS

On Socialist Constitutions



Ivan Sablin's ERC ENTPAR project produced yet another fascinating workshop, this time dedicated to *Socialist Constitutionalism and Diversity Management since the 1970s*. Held in Heidelberg on 12 and 13 May 2022, it brought together researchers working on East-Central Europe, former Soviet Union, as well as China. The presented research, largely work-in-progress, showed highly diversified constitutional

On German Parliamentarism since 1815



The book *Parlamentarismus in Deutschland von 1815 bis zur Gegenwart* edited by Andreas Biefang, Dominik Geppert, Marie-Luise Recker and Andreas Wirsching is much more than a jubilee volume. The KGParl managed to put together a synthesis of modern German parliamentarism that stretches from explaining the parliamentary tradition and its aftermath in contemporary Bundestag, to illustrating the latest approaches in studying parliamentary history, addressing gender issues and institutional contexts.

Revisiting the Nineties

The Czech Institute of Contemporary History responded to the wide popular debate on the transformation era of the 1990s that recently unrolled. Inspired by the *Devadesátky* TV series, that depicted skyrocketing crime rates after 1989, including racketeering, torture and murder in the new private business, the Czech public seemed divided over the democratic and other narratives of the era. The workshop brought together leading historians and political scientists to try to formulate

REPORT

Parliaments and Pandemics

The international workshop *Parliaments in Pandemics* was held in Prague in hybrid mode on 26–27 May 2022. It was convened by the Institute of Political Science at Charles University FSV Faculty and the IPSA Research Committee of Legislative Specialists. The latter had responded to lockdowns and academic isolation in a highly creative manner. Within the Parliaments in Pandemics (PiP) project, they carried out a series of comprehensive specialist panel surveys in 2020 and 2021 to find out how the parliaments across the globe coped with the situation.

Sven Siefken opened the workshop with a keynote on the first findings of the PiP network survey. These seem to suggest that, rather than experiencing much of a long-term “learning through the crisis”, most parliaments responded to the shock brought about by the first-wave by introducing some operational changes, and then continued in relative stability. The three panels reflected on the effect of COVID-19 on the functioning of parliaments, including their digitisation, public perception and relationship to other governmental bodies. Petra Guasti

explored the pandemic as a technocratic challenge for democracy. She demonstrated how technocracy undermined the principles of accountability and oversight and aggrandized the role of leaders. Adéla Gjuríčová attempted to shift the political–science and political–sociology mainstream at the workshop toward historiographical approaches, asking how

the study of parliamentary culture can enrich the interpretation of parliaments in crises.

The event arranged by Petra Guasti and Zdenka Mansfeldová turned into an intriguing meeting of political scientists, sociologists and historians from three continents. Do join the research committee to receive RCLS newsletter [here](#). Updates on the survey on [PiP twitter](#).
